You spoke to this group last on May 14, 2000 during a candidates forum. You discussed children with serious emotional behavioral disorders or mental illness. Mississippi Families as Allies recommends a type of service delivery that is called a System of Care or Wraparound. A system of care involves a partnership between many entities such as schools, churches, mental health, juvenile justice, social services, families and foster families.

The formation of COMPASS is due to:

- i. Efforts in 1993 and 1996 creating the Mississippi Connections Project
- ii. Cooperative effort of all agencies at the state and local level
- C. COMPASS guided by the input of families and children on all levels practice, program and policy.
 - i. Based on state-of-the-art practice in children's mental health including:
 - 1. keeping children in their communities, homes and schools
 - 2. strengths-based partnerships with families

- 3. creative blending of funding and services across systems and agencies
- 4. incorporation of informal supports into interventions with children

5. cultural competence

- 6. closely evaluating the outcomes of thee services delivered
- ii. Five year grant increasing from \$1,000,000.00 during the first year to \$2,500,000.00 during the peak years (a 1:3 match is required during the first year, with this becoming 3:1 by the fifth year)
- D. Funding the grant money is seed money that will get the project started. It is up to us to find the permanent funding for COMPASS. We must do all that we can to help our children –
 - i. Finding new funding

ii. Pooling funds

Department of Mental Health, Education and Human Services have already committed to providing the matching dollars required by the funding source.

House Bill 250 (is due from Gov. 5-23-00), supports blended funding efforts and inter-agency collaboration.
