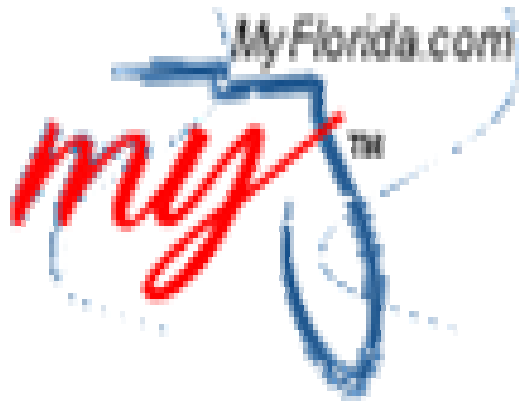

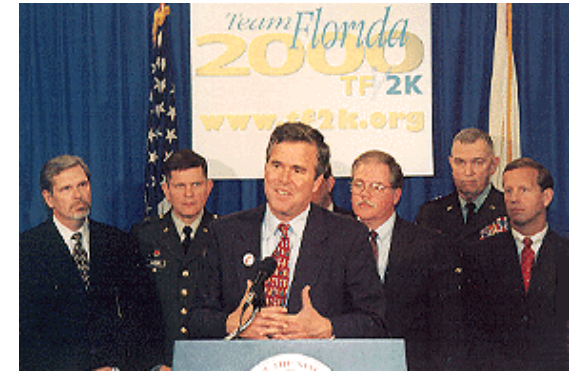

Article V - Revision 7

November 3, 1998

Voters of the State of Florida passed an amendment to the Florida Constitution

- ◆ Article V involves the state's Judicial Branch
- ◆ Significant changes were made in the way the Florida courts are to be funded

- Provide for common data administration



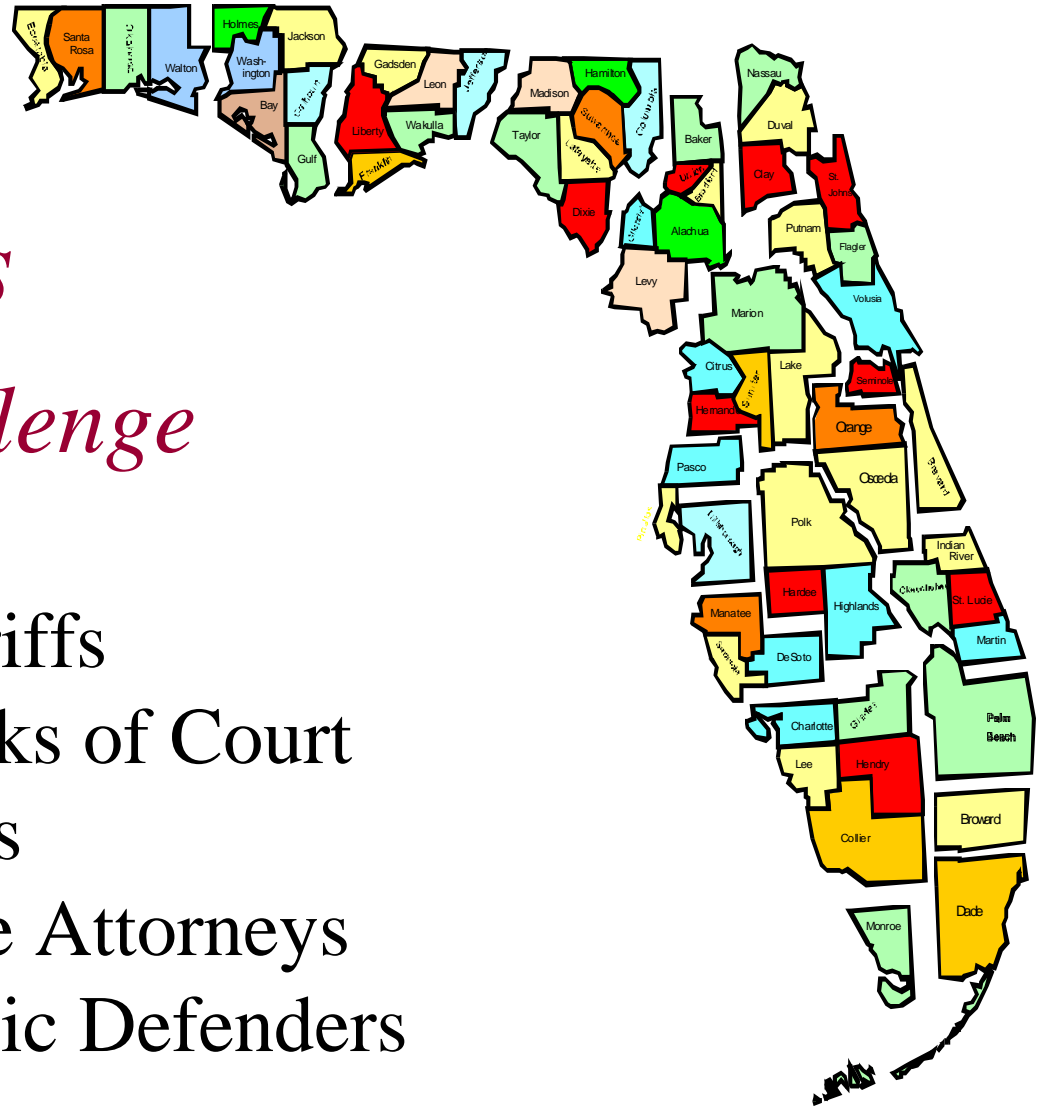

- 67 elected Sheriffs
- 67 elected Clerks of Court
- 20 Chief Judges
- 20 elected State Attorneys
- 20 elected Public Defenders

Policy Development for Integration

- Principles for Public Safety Information Technology Resources in Florida Statutes
 - ◆ Cooperative planning
 - ◆ Including all principals from the outset
 - ◆ Maximizing information sharing
 - ◆ Maximizing public access, while addressing security & privacy requirements
 - ◆ Electronic sharing of information via networks
 - ◆ Sharing data without charge
 - ◆ Eliminating redundant data capture



Statewide Database Policies

These principles also in Florida Statutes:

- Maintain only data that are auditable, or that can be determined to be accurate, valid, and reliable.
- Share data among different agencies without requiring major redesign of individual systems.
- Integrate data by establishing standard definitions, formats, and integrated electronic systems.



Development of Standards

- Telecommunications Standards -- TCP/IP
- CJNet Applications -- Web Enabled
- Minimal Hardware Standards
- NIST Fingerprint and Image Standards
- Criminal Justice Data Element Dictionary
 - ◆ Data from Clerks of Court for 4 state agencies
 - ◆ Developed cooperatively by providers & consumers of data
- Other National Data Standards



Common Infrastructure

Criminal Justice Network

CJNet

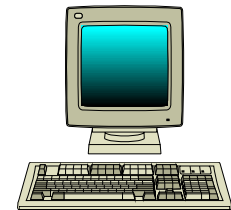
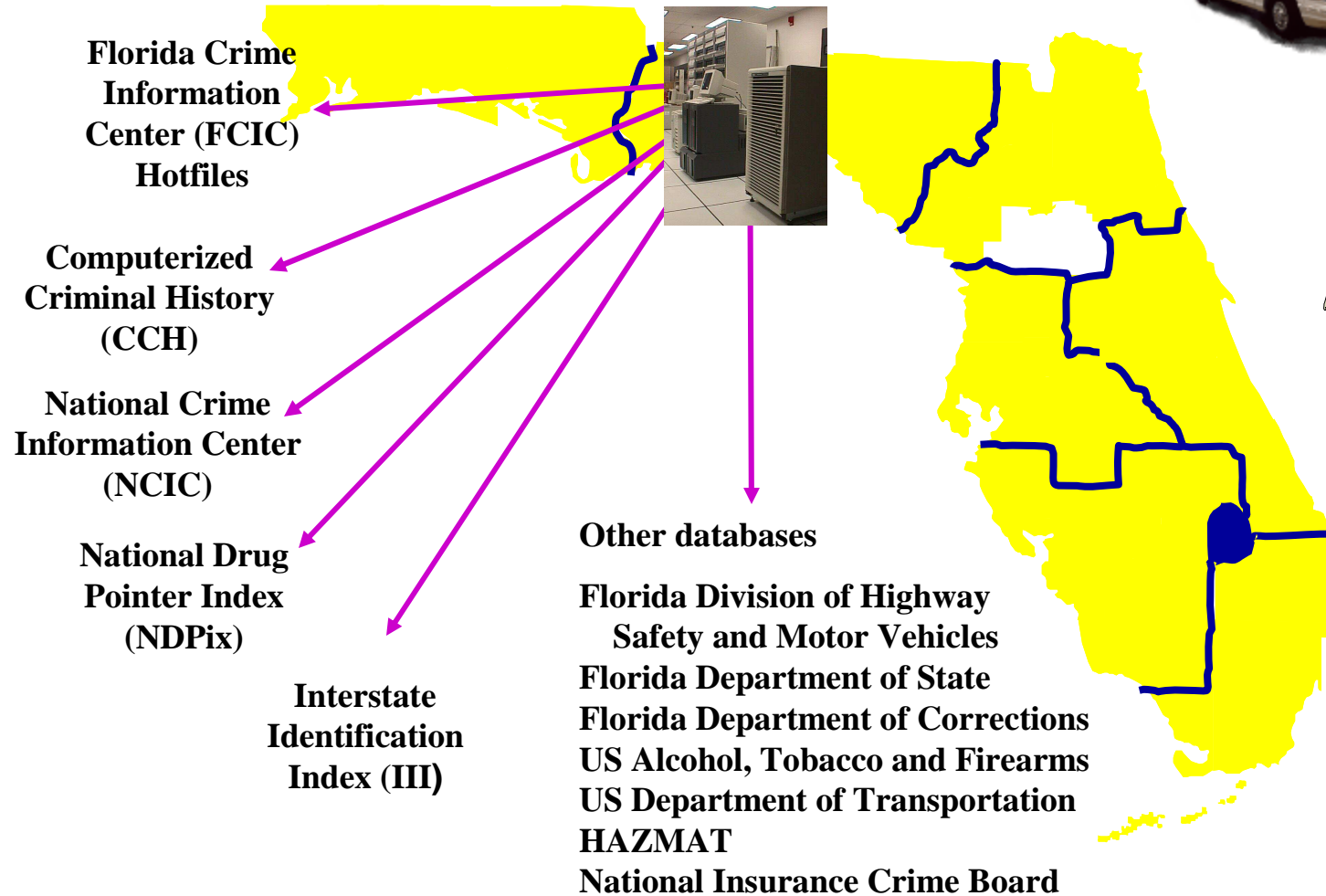
Secure closed statewide network to share information among criminal justice agencies

- Managed by Florida Department of Law Enforcement
- Capable of accessing multiple data sources via a single network
- Provides e-Mail Services
- Allows Inter-agency file and image transfers
- Allows agencies to share data and applications
- Provides PKI Certificate security capabilities

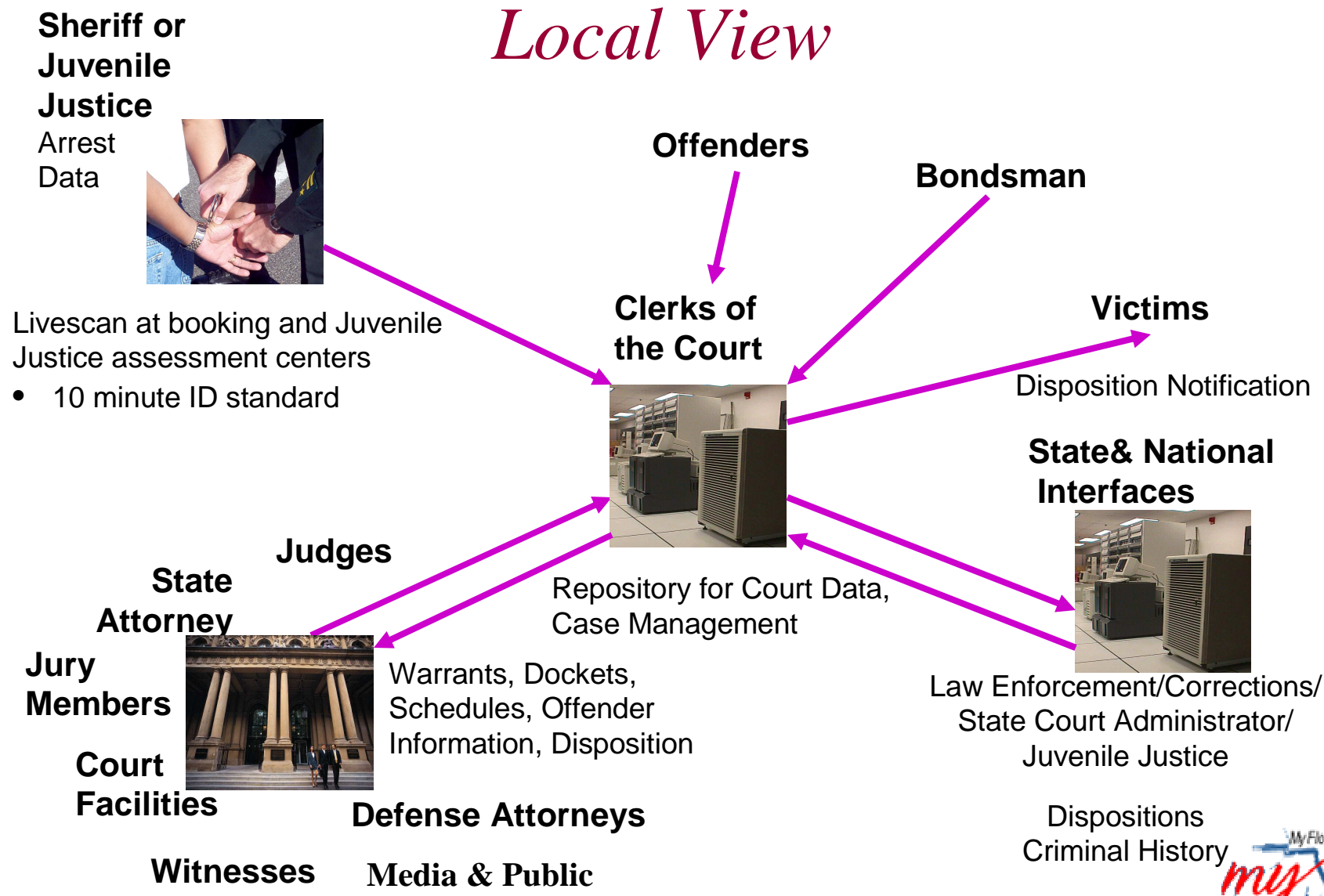

ICHS Vision

- Protect law enforcement officers and public
 - ◆ Provide information about crimes and criminals
- Improve information services to stakeholders
- Build infrastructure for criminal justice information for this century
 - ◆ Adequate capacity to support anticipated needs
 - ◆ Plan for emerging technologies



ICHS

Functional Goals

- Re-engineer a 30+ year old criminal history system
- Base functionality on user input and new technology
- Integrate Automated Fingerprint Identification System (AFIS) with Central Criminal History
- Reduce redundant data entry
- Improve reporting capabilities
- Meet all state and national standards
- Full Implementation - June 30, 2003

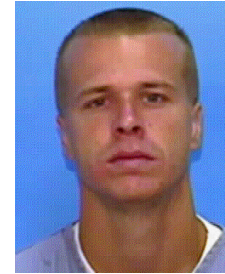

ICHS - Initial Requirements



- Relational database
- Update from single entry of data at source
- Add and modify fields easily
- Link to other database records
- Include images
- Create new and improved
RAP sheets
- Create on-line reports
- Increased capacity
- Provide more data on offenders
- Provide better audit trails on records
