SGPB is seeking exemplary programs in the following four programs:

1. **Human Capital**: the skills and abilities that are a vital element in assuring economic growth and individual advancement and the reduction of inequality.

- Training programs developed through clusters
- 2. **Financial Capital**: financial resources/programs to facilitate the creation and expansion of entrepreneurship in the South.

## Suggestions:

- Programs that utilize various forms of financing (i.e., angel, mezzanine, private capital, venture capital)
- Programs that raise capital online
- Programs that finance minority innovation
- 3. **Social Capital**: connections among individuals and entrepreneurs social networks that give rise to trust and deeper collaboration.

## Suggestions:

- Citizen groups working to solve community problems
- Mechanisms that allow businesses to network with each other

- Civic engagement initiatives designed to get people more deeply involved in their communities
- 4. **Intellectual Capital**: the ability to create, innovate and bring products to market.

Suggestions:

- Innovative linkages and partnerships to strengthen R&D
- State policies and programs

The Fair can accommodate three programs from each state. Innovators will be selected based on five criteria: originality of project, state representation, innovative funding arrangements, sustainability of their creative approaches, and economic and social impact at the state and regional level.

The Governor's Office will submit five nominations on behalf of the State of Mississippi. Due to approaching deadlines, we must receive your nomination(s) by Tuesday, February 13. You may submit two (2) nominations from your agency. You must provide the following information for each nomination:

- Program category (financial, human, intellectual or social capital)
- Program name
- Program description (75 words or less)
- Website (if applicable)
- Contact (name, address, phone, fax and email)
