Governor's talking points

- Many of these same people joined me on March 12 to announce that early childhood education would be a priority for my administration (LAM/JS check wording from his March comments)
- We are here today to announce a partnership that will result in a needs assessment of our state being conducted that will provide us with a blueprint of implementing and funding early childhood education
- Higher education leadership summit in January 2002 recognized early childhood education and every child starting school ready to learn as a priority.
- Many existing early childhood initiatives (LAM/JS name some from the March press conference)
- However, no comprehensive plan for the funding and implementation of a universal early childhood education system.
- DHS is providing \$375,000 in child care development funds to the BRI to enlist the services of Dr. Sharon Lynn Kagan to conduct an 18-month needs assessment that will evaluate the status of child care, the cost of upgrading childcare in MS, and potential funding sources
- Dr. Kagan is a senior research analyst at Yale University and is one of the nation's leading authorities on early childhood development. She was the principal author of the 2001 report entitled "Not by Chance: Creating an Early Care and Education System for America's Children" this report offers potential long-term solutions for improving the quality of early care and education
- Governor sent letter on 2/28/02 inviting Dr. Kagan to work with us in establishing universal funding for an early childhood care and education system
- Dr. Kagan has conducted similar work in Ohio and she is currently working with the states of Illinois and South Carolina.
- Dr. Kagan and Richard Brandon of the University of Washington's Human Services Policy Center will serve as Co-Directors of this project. MSU's Early Childhood Institute will provide support services for Dr. Kagan and Mr. Brandon.
- Dr. Kagan will assess what child care services exists, what funds (federal and state) would be available to support an enhanced child care system and she will also gauge (via focus groups) what the public wants as far as child care. When her work is finished, she will basically give us a menu of programmatic options of what we can do to improve early care, the cost of each option and possible resources for funding each option.

- Barksdales committed \$100 million three years ago to create the BRI to give teachers the tools to help at-risk elementary students learn to read on their grade level. They are now expanding their focus to include the impact of early care on children being prepared to start kindergarten and first grade ready to learn.

- Thanks to the MS Early Childhood Association for providing funding to offset local costs, such as the focus groups.
