Dear R.H. Bearden Elementary School:

Congratulations on being selected as a Following the Leaders (FTL) school! Your leadership is inspiring and your willingness to step forward to lead the nation is truly to be commended. FTL partners are very excited to be working with you over the course of the next year to improve teaching and learning with the end goal of increasing student achievement. We know, however, that no matter how exciting or powerful a new program or tool might be, implementing something new in a school is never easy. All of us at Following the Leaders are impressed and amazed at how quickly you were able to mobilize resources to begin implementation this fall. We also know though that no matter how terrific your leadership is, new programs and compressed timelines can cause anxiety especially when they change the way in which teachers work. We've done a lot of thinking at Following the Leaders with respect to how we can provide a plan, and resources, to you to mitigate that anxiety as we get FTL off the ground in your school. Our rollout plan has five design principles at work.

First, components of the FTL Project Achieve software suite have been implemented in over 1,000 schools in 43 states. Although we know no two schools are exactly alike, we've designed our implementation to reflect 'best practices' in those prior implementations.

Second, we have designed your roll-out to begin the *teacher* part of your implementation with modules of FTL (SkillsTutor and the Achieve Resource Center) that are easy to implement and demonstrate to teachers, quickly, some of the benefits of using Achieve.

Third, every module we are releasing to you prior to when the Project Achieve project leader will be assigned (October 30th) has significant on-line training or support. As you may recall from the application process, Project Achieve's locally-based project leader will work with your school throughout the school year. We recognize that all implementation work that is to be done in advance of his/her arrival needs to be do-able without that kind of support. So, we have designed on-line tutorials/training so that teachers and/or administrators have exactly the kind of initial support they need. All of the modules that are being released prior to when you will have a project leader on site – as early as October 30th – have on-line training (ARC, Project Achieve Overview, SkillsTutor), or a step-by-step wizard (Setup Wizard/Administrator Console of Achieve 3.0, SkillsTutor) to help you or your teachers get going.

Fourth, we've chosen modules that serve as building blocks and that, within the first month of your participation, will give us a good idea of your willingness to be a part of FTL during the duration of the 2002-2003 school year. We had hundreds of schools apply to participate and, as you might imagine, we want to make sure that the small number that were selected to be national leaders are willing and able to make the most of their opportunity. We know how compressed the application cycle has been and how quickly you have needed to get your application in. For some schools, you may have needed to get your application in before you had a chance to actually do the spadework you might have wanted to with your staff. We know how critical staff buy-in is. That's why we've set the date for the final list of FTL schools for October 29th. That gives you over a month to get the ball rolling. For example, as of September 23rd, the Set-Up Wizard is available to you. Getting basic data into the system is necessary for teachers to be able to use the lesson builder, standards-linked gradebook and many of the other modules that will be released to you on October 18th. If the set-up is not done, even though you'll have a Project Leader assigned to you, s/he won't be able to do anything with you or your staff given that basic set-up has not been completed. As such, as you'll see in the table below, one of the conditions for remaining in the FTL program is having that initial set-up complete by October 29th. Each of the

criteria that will be used to determine the final list of Following the Leaders schools is shaded in gray in the table on the following pages.

Fifth, when Project Achieve President Stacey Boyd met with you in late August she presented the Following the Leaders timeline for participating schools. It was already incredibly compressed given the delay in the announcement of the U.S. Department of Education grant. As you may know, delays in the school application process (due in part to scheduling conflicts that pushed back information sessions in some states), schools were announced a couple weeks later than anticipated. We obviously don't believe it is right to compress the timelines presented in the information sessions for schools since the announcement of FTL schools were 100% out of their control. Announcements of FTL participation is approximately 21 days late and, as such, the implementation timelines have been pushed back three weeks as well. In short, the timeline you committed to when you applied is the same. Everything is simply pushed back by several weeks. The dates you committed to in your applications are now void. These dates that follow are the new ones. And, as you will see in the table that follows, all critical information for the milestones, ours and yours, are included in the additional sections of the "FTL Welcome Kit."

Project Achieve Overview

As part of the Following the Leaders initiative, Project Achieve is providing pilot schools with a variety of software and implementation services, including the Achieve Resource Center, SkillsTutor, and Achieve 3.0 (which includes several modules, including the Lesson Builder, Curriculum Planner, Standards-Linked Gradebook, and others). A complete description of the software modules offered as part of Following the Leaders is included in the "Overview of All FTL Project Achieve Software and Services" section of this Welcome Kit.

We have designed an hour-long on-line tutorial to give you an overview of Project Achieve's FTL software and services. Narrated by Project Achieve President Stacey Boyd, it describes product functionality, explains the role of the project leader, and outlines the roles and responsibilities of the Achieve Leadership Team (ALT), the group of 3-5 leaders at your school designated by your principal, who will spearhead implementation of Following the Leaders at your school.

Who should view the on-line tutorial?

At a minimum, the Achieve Leadership Team should log on and view this presentation. Each member of the ALT must view the tutorial by October 29th as part of your school's continued FTL participation for the 2002-2003 school year. Please note that there is a short quiz at the end of the presentation; however, you can take the quiz as many times as you'd like and quiz results do not impact your school's FTL participation.

In addition, all teachers at your school will have access to this tutorial. Letter to Parents

We are launching Achieve's "Teacher Console" this fall with our teachers and staff. And, in January, you too will be able to access Achieve's "Parent Console". If improvements have been made to the technology infrastructure at your school, please notify Project Achieve. If via email please send to support@projectachieve.com. If via fax, please send to 415-645-9001.

What happens when we meet the continuation criteria?

On or about October 30th, Project Achieve will assign a project leader to work with your school for the 2002-2003 school year. Your project leader will work closely with your school's Achieve Leadership Team to schedule teacher training and other consultations that you deem appropriate to ensure an effective and successful implementation of FTL at your school.

What happens if we do not meet the continuation criteria?

If it appears that you are at risk of not meeting the continuation criteria, Project Achieve will notify you on approximately October 22nd. This gives your school one week to remedy the situation. If, by October 29th, it appears that your school has not met the continuation criteria, you will receive a notification on that date and access to the Achieve software (including SkillsTutor and the Achieve 3.0 Setup Wizard/Administrator Console) will be suspended. Your school will continue to have access to the Achieve Resource Center, which is available statewide.

Project Leader Role

Implementing Achieve 3.0 involves communication and change management. It requires leadership and expertise in the art of information management, thoughtful data-driven decision making. It also requires knowing how to successfully shepherd teachers and principals through change and methods to coordinate and lead a systemic reform effort among groups of schools.

Project Achieve was founded by a team of educators who believe that with enough tools and the right support, schools can achieve anything. We have worked with schools from California to Massachusetts, supporting them every step of the way as they implemented Achieve. Working hand in hand with your school's Achieve Leadership Team, we believe that our project leaders will play a critical role in the success of Following the Leaders at your school. Each project leader works with a cohort of 10 to 15 schools over the first two years to shepherd change. You should consider them your partner as you pioneer the Following the Leaders program.

What does the project leader do?

Your project leader will play several roles at your school:

- Work with your school's Achieve Leadership Team to customize an annual implementation plan based on your collective vision for how to maximize the impact of Following the Leaders at your school
- Coordinate and lead training sessions for teachers, principal and staff
- Communicate latest product features and functionality on an ongoing basis
- Collect your feedback on our products and communicate them to Project Achieve's product development staff

How often will our project leader visit our school?

Because your project leader works with a geographically-clustered group of schools, s/he will be able to dedicate a couple of hours to your school, on average, every other week throughout the school year. You can expect a project leader to be at your school for a total of 25 hours in a given school year and s/he will work with you to find training times that are convenient for your staff. Please note, however, that because the project leader is responsible for a dozen plus other schools as well, if you should cancel a training within 72 hours of when the project leader is scheduled the time that would have been spent with your school will be deducted from the 25 hours.

What is the typical background of a project leader?

Project leaders realize that implementing Achieve is more than simply software training. They typically have had at least 2-3 years of first-hand teaching experience, often much more. They have experienced the challenges, and devised ways to overcome the challenges, of implementing new technology in schools. They combine project management experience with ongoing training from Project Achieve to make sure that they help you devise and execute an effective implementation plan for Achieve over the first two years.

When do we meet our project leader?

A project leader will be assigned to your school on or around October 30th, when all of the criteria for continuation in Following the Leaders has been met. At that time, s/he will contact your principal to schedule a time in the subsequent two weeks for a face-to-face "kick-off" meeting.

Overview of All FTL Project Achieve Software and Services

(In alphabetical order)

Administrator Console (Set-Up Wizard), available to FTL pilot schools, allows school administrators to establish parameters and policies in Achieve 3.0 specific to their schools. The set-up wizard guides the administrator through the set-up process providing tips along the way. It provides default values such as course lists, assessment types, etc. that can be used as is or modified as necessary. A set-up guide can be printed and used to collect the information needed to set a school up on Achieve. *This module is available in September.*

The Achieve Resource Center, or ARC, is a Web-based tool that helps teachers and administrators search or browse a library of third-party, public domain educational resources aligned to your state's standards. Such educational resources accessible via the ARC have been reviewed, evaluated for quality and correlated to state academic standards. Functionality includes a resource finder, standards browser and a resource browser. With the resource finder, end users can perform web-based searches for educational resources based on the numerous criteria, including by not limited to: grade level, subject area, resource type, key words, intended audience, teaching method, learning style and grouping. Search results are sorted by relevance based on key words and display a description of and a link to third-party educational resources that meet the requested criteria. With the standards browser end users can locate web-based resources by state standard. Browse results display a description of and a link to educational resources that relate to a given state standard. With the resource browser, end users can locate web-based resources by subject and topics. Browse results display a description of and a link to educational resources that relate to a given subject area. When reviewing search results or browsing by subject and topic, users are able to see the relevant state standards that correlate to any resource so displayed. The ARC is available as a standalone web site to all teachers in your state, and is also included in the integrated Achieve 3.0 application available to FTL pilot schools. This module is available in September.

Classroom Assessment Analysis Drilldown is a reporting function in Achieve 3.0 that allows users to view standards mastery results based on classroom assessment starting at the school level. Drill down capability is provided to allow the user to select a section and see the mastery results, and then continue drilling down to further levels of detail until viewing the individual student mastery. *This module is available in December.*

Discipline allows teachers to record discipline incidents in Achieve 3.0, and share that information with the principal and other teachers. *This module is available in October.*

Lesson Builder and Curriculum Planner are functions in Achieve 3.0 that allow end users to write lesson plans, to link those plans to relevant state standards and to store links to relevant educational content and assessments. When using the Curriculum Planner to write lesson plans, Achieve 3.0 automatically recommends educational resources from the ARC to the end user, based on the learning concepts and skills covered in the lesson plan as identified by the end user. When using the Curriculum Planner to write lesson plans, Achieve 3.0 automatically displays the number of times a standard has been taught and students' current mastery level of each standard for the standards covered by the lesson plan as identified by the end user. Data from curriculum planner is displayed on a daily, weekly or monthly basis. Based on data from curriculum planner, reports generating student-specific summary of the learning objectives and state standards to be covered in that student's classes over a specified period of time can be run. Based on data from curriculum planner, end-users can run reports that tabulate how many times specific state standards have been taught to a given student, class or school. Also based on data from the curriculum planner, teachers and administrators can run reports generating

student-specific summary of the homework assignments to be assigned in that student's classes over a specified period of time. *This module is available in October.*

The **Lesson Plan Library** in Achieve 3.0 enables teachers to share the lessons they have created with their colleagues by putting them in the lesson plan library. The library is a central repository of lessons created by teachers at the school. Users can copy lessons from the library and use them as a basis for creating new lessons. *This module is available in October.*

Online Assessment Analysis (SkillsTutor) Drilldown is a reporting function in Achieve 3.0 that allows users to view online assessments starting at the school level. Drill down capability is provided to allow the user to select a section and see the assessment results, and then continue drilling down to further levels of detail until viewing the individual's assessment results.

Parent/Student Console provides parents with online access to information for their students that has been input by the students' teachers in other modules of Achieve 3.0, including homework assignments and grades. *This module is available in January*.

Principal Console gives school principals global access to final lessons and assessments for his/her school in Achieve 3.0. Reports are included that allow the user to monitor the school's progress towards standards mastery. *This module is available in October.*

Set-Up Wizard is typically the first interface that a school administrator will see of the Administrator Console, and is used to facilitate setup of the school on Achieve 3.0. Please see **Administrator Console (Set-Up Wizard)**. *This module is available in September.*

SkillsTutor is a Web-based assessment application that includes 1,000 learning activities based on two decades of research and refinement. It helps teachers quickly identify gaps in knowledge and assigns appropriate instructional content. SkillsTutor offers individual lesson plans for students of widely varying skill levels and provides students practice with assessments that mirror state test and format. All content is aligned to all 50 states and major tests, in the following subjects: Reading, Math, Science, Algebra, Language, Writing, Information Skills, and Workforce Readiness Skills. SkillsTutor, which is available to FTL pilot schools, comes complete with standardized reporting for the administrator to measure progress. *This module is available in September.*

Standardized Testing Assessment Analysis Drilldown is a reporting function in Achieve 3.0 that allows users to view standardized test results starting at the school level. Drill down capability is provided to allow the user to select a section and see the test results, and then continue drilling down to further levels of detail until viewing the individual's test scores. *This module is available in January.*

Standards-Linked Gradebook is an online gradebook in Achieve 3.0 that enables end users to link relevant state standards to classroom assignments. End users can input qualitative and quantitative assessments of student performance, view summary calculations and report student performance in terms of traditional grades as well as achievement relative to the linked state standards. End users can store links to actual assessments and to student work allowing them to create student portfolios. Based on data gathered from the student gradebook, end users can run Standards Mastery Report that is an on-going tabulation of student performance on specific state standards by a student, class or school. *This module is available in October*.

Student Monitoring in Achieve 3.0 allows teachers to record qualitative feedback on student performance to be shared with parents and other teachers. *This module is available in October.*
