# Four South Mississippi Correctional Institution Employees Receive Employee Recognition Awards

Leakesville – Four South Mississippi Correctional Institution (SMCI) employees were presented Mississippi Department of Corrections (MDOC) recognition awards today by Commissioner Robert L. Johnson. SMCI Superintendent David Turner assisted Commissioner Johnson in presenting the awards. SMCI is located near Leakesville in Greene County.

The awards presentation ceremony was part of a monthly statewide employee recognition program instituted by MDOC in July. The program is designed to recognize exemplary employees within MDOC's ranks for outstanding service to the prison system.

"It is a personal honor for me to present these recognition awards to this group of outstanding dedicated employees," said Commissioner Johnson. "Our agency is blessed with countless numbers of professional public servants who provide crucial security for the operation of our prison system." Commissioner Johnson added, "I salute all of the dedicated men and women within MDOC's ranks for their untiring public service." The Mississippi Department of Corrections currently employs over 3700 employees statewide who maintain vigil around the clock protecting public safety.

SMCI began its operation as a 500-bed medium security institution in April 1989. It presently has 550 people in its employ and the prison houses over 2100 offenders on a daily basis. SMCI has a capacity to house 2214 prisoners.
