MDOC will hold ceremonies each month to officially recognize outstanding employees at all three state institutions (Mississippi State Penitentiary in Parchman, Miss; Central Mississippi Correctional Facility in Pearl, Miss; and South Mississippi Correctional Institution in Leakesville, Miss.) and at the MDOC central office in Jackson.

Central Office Recognition Award Recipients

Rita Twiner, purchasing agent for the MDOC central office, was nominated by Lora Cole, Interim Deputy Commissioner of Community Services. Twiner, who was been with MDOC since 1999, is in charge of all the purchasing functions for the central office of MDOC and is over the purchasing department at Central Mississippi Correctional Facility in Pearl. "In these very tight budget months, it is reassuring that MDOC has a purchasing agent who takes her job seriously and is willing to go the extra mile to ensure that the agency's and tax payer's funds are handled prudently," said Cole.
