Ten Central Mississippi Correctional Facility Employees Receive Employee Recognition/Service Awards

Pearl – Commissioner Robert L. CMCF is the central receiving point for the processing of offenders sentenced to the supervision of MDOC.

"I wish to personally salute each of the service award recipients and also to acknowledge my deep appreciation to all of our loyal, dedicated men and women here at CMCF for a job well done," said Commissioner Robert L. Johnson. "Your public service role in corrections is highly important to public safety," said Johnson. "Most people don't see what we do – that's why we started the awards recognition program to let everyone know about the hard work our employees are doing and how important your jobs are to public safety."

Commissioner Johnson, joined by CMCF Superintendent Lawrence Kelly, presented each employee with lapel pins and certificates. Additionally, the Staff Employee of the Month and the Correctional Officer of the Month received plaques in appreciation for their dedicated service to the prison.

"During 2001, our Reception and Classification center processed over 7,250 offenders into the prison system," said Superintendent Lawrence Kelly. CMCF began operation in 1987 as a prison and a reception and a classification facility. Today the prison employs over 650 personnel to operate the 3,049-bed facility located on state owned land near Mississippi State Hospital at Whitfield. Superintendent Kelly noted that due to the rapid growth of the prison system in recent years, CMCF's mission has been expanded.

Kevin Nunn, Correctional Officer III, of Jackson, was presented the Correctional Officer of the Month award. Nunn, a six-year veteran with the prison system, was nominated CMCF Warden Jackie Parker. "Nunn is a hard-working dedicated employee who willingly accepts added responsibilities," said Warden Parker. Officer Nunn was commended for his valuable role as interim supervisor over the prison Transportation Department, a position he has held since December 2001. He was further commended for the outstanding management leadership, which according to Warden Parker has greatly enhanced the operation of CMCF's transportation department.

Smitty Jordan, ACA Accreditation Manager, of Pearl, received the Correctional Employee of the Month award. Nominated by CMCF Jackie Parker, Jordan, a four-year veteran with the prison system was characterized as an extremely professional employee. Jordan was commended for his leadership role in helping CMCF III to become the first MDOC facility to attain ACA accreditation in January 2001. "Jordan has a vast knowledge of the ACA process," said Parker. "He has made it much easier in our current effort to attain full of our 3,049 bed complex at CMCF." Jordan was commended for his willingness to provide assistance CMCF's accreditation team whenever called upon to solve complex issues. Jordan was praised for his continuing role of assistance to prison administrators in on-going efforts by officials to meet a targeted October 1 date to reach full ACA accreditation at CMCF.
