MDOC will hold ceremonies each month to officially recognize outstanding employees at all three state institutions (Mississippi State Penitentiary in Parchman, Miss; Central Mississippi Correctional Facility in Pearl, Miss; and South Mississippi Correctional Institution in Leakesville, Miss.) and at the MDOC central office in Jackson.

Community Services Division Service Award Recipients

Monica Harper, of Jackson, is a teacher in the pre-release center at the Flowood Community Work Center. Harper was nominated for the Extra Effort Award by Caroline Banyard, director of the pre-release center at Flowood CWC. Harper teaches adult basic education classes to female offenders nearing their release date. The classes that Harper teaches include personal development, life skills and employability skills.

"Because of a teacher vacancy at the Flowood CWC, Ms. Harper has taken on the additional responsibility of providing alcohol and drug education to the pre-release participants and the twelve-week alcohol and drug classes for the general population," said Banyard. "She is dedicated, competent and an enthusiastic employee."

Jenifer Harris, of Pickens, is a pre-release counselor at the Flowood Community Work Center. Harris was nominated for the Extra Effort Award by Caroline Banyard, director of the pre-release center at Flowood CWC. Harris is responsible for providing counseling, job coaching, job development, job referrals, employer contacts and follow-ups to pre-release participants.

"She is dedicated in assisting her clients with finding jobs," said Banyard. "Ms. Harris is a team player, ambitious and willing to accept any challenges or opportunities that are offered to her, without hesitation."

Larry Mayo, of Raymond, is a field officer III at the Hinds County Probation & Parole office in Jackson. Mayo was nominated for the Extra Effort Award by Tara Frazier, the Victim Services Director. Officer Mayo is known for taking a personal interest in serving crime victims by referring them to the Division of Victim Services.

"His professional interest, initiative and drive has been shown in court when meeting crime victims," said Frazier.

"He takes responsibility in making sure crime victims are aware of the Division of Victim Services."
