"CMCF is the central receiving point for the processing of offenders sentenced to the supervision of MDOC," said Warden Holman. "Our reception and classification center processed over 7,250 offenders into the prison system during 2001." He added, "It is a continuous and difficult process. However, thanks to our dedicated staff, we continue to handle our assignment with accuracy and dispatch." CMCF currently has 660 in its employ to operate the 3,049-bed facility.

Burnette Harris, Correctional Officer II, of Jackson, was presented the Correctional Officer of the Month Award. Nominated by CMCF II Interim Warden Tony Compton, Officer Harris, a six-year veteran with the prison system, was commended for his attention to detail, his unfailing accuracy and for his diligence to see each assignment through to a successful completion. "Officer Harris is dedicated to making the prison environment as secure as possible," said Warden Compton. "Because of his thoroughness and his attention to detail, he constantly confiscates items that might pose a threat to security. We are most fortunate to have a person with his drive and dedication here at CMCF."

Myrtis Hollis, Radio Operator, of Jackson, was presented CMCF's Staff Employee of the Month Award. Nominated by Correctional Commander Jerry Williams, Ms. Hollis, a three-year veteran at CMCF, was characterized as being a valuable link in the internal communications network at the prison. "Communication is critical in a prison's operation and Ms. Hollis is superb in her highly critical role as radio operator here at CMCF," said Captain Williams. "Regardless of the emergency, she never gets flustered. We are indeed fortunate to have her as part of CMCF's team."

Michael Humphrey, Correctional Officer III, of Jackson, a 7-year veteran with CMCF, received the Extra Effort Award. "Officer Humphrey is a team player," said Deputy Warden Eydie Winkle who nominated him for the award. "Aside for his management skills, Officer Humphrey's interpersonal skills win him immediate support from his co-workers. He is an enjoyable person to be around, but equally important he plays an important role in the overall security here at CMCF." Officer Humphrey currently serves as the chemical officer at CMCF I and has the responsibility of making sure that they are properly distributed. He also has the added responsibility of serving as a Security & Escort Officer at CMCF.

Leanette Jordan, Assistant Director of Offender Services, of Pearl, received CMCF's Extra Effort Award. Ms. Jordan, a 20-year veteran with the prison system, was nominated by Warden Jackie Parker. "I have had the distinct pleasure to work directly with Ms. Jordan over the past 16 years," said Warden Parker. "Ms. Jordan's valuable contributions to the Offender Services' classification program at CMCF are inestimable. Her untiring manner... early to work and even to work on weekends to ensure assignments are completed in a timely manner make her a very special person."

Maggie Woodard, Secretary, CMCF II, of Jackson, and a 13-year veteran with Central Mississippi Correctional Facility received the Extra Effort Award. Nominated by Deputy Warden Rufus Burks, Ms. Woodard was saluted as a truly devoted employee. "Ms. Woodard is a people person and she assiduously works to attain perfection, regardless of her assignment," said Deputy Warden Burks. "Through her untiring efforts to broaden her knowledge about the many complexities of the prison operation, she has become diversified in her skills and abilities. She is a very valuable employee!"
