Six Central Mississippi Correctional Facility Employees Receive Employee Recognition/Service Awards

CMCF is the central receiving point for the processing of offenders sentenced to the supervision of MDOC.

Commissioner Johnson, joined by CMCF Superintendent Lawrence Kelly, presented each employee with lapel pins and certificates. Additionally, the Staff Employee of the Month and the Correctional Officer of the Month received plaques in appreciation for their dedicated service to the prison.

CMCF began its operation in 1987. It was originally designed to serve jointly as a women's prison and as a central receiving point to classify all new offenders sentenced to the supervision of MDOC. "With the rapid growth of Mississippi's prison population during the 80's and 90's, the role of our facility has changed significantly," said Superintendent Kelly. "During 2001, our Reception and Classification center processed over 7,250 offenders into the prison system and today CMCF employs over 650 personnel to operate the 3,049-bed facility."

Rhonda Gunter, Administrative Assistant of Pearl, was presented the Employee of the Month Award. Gunter, a three-year veteran with the prison system, was nominated and commended for her outstanding administrative skills by CMCF Superintendent Lawrence Kelly. "Gunter has a unique ability to manage multiple tasks simultaneously," said Kelly. "She operates extremely well under pressure and easily shifts between handling calls from inmates' family members to reading and replying to correspondence." Gunter was commended for her untiring dedication to her job and her willingness to help others whenever she is called upon. Superintendent Kelly added, "She is one of those remarkable individuals whose job performance is excellent and who never complains despite the enormity of the assignment."

Barbara Hunt, Correctional Officer I of Carthage, received the Correctional Employee of the Month award. Nominated by CMCF II Deputy Warden Rufus Burks, Officer Hunt, a two-year veteran with the prison system was characterized as an extremely professional employee. "Officer Hunt posses all of the ideals of a truly dedicated correctional officer," said Deputy Warden Burks. "First and foremost, she is a team player." Burks added, "Officer Hunt goes beyond the call of duty, and if the need occurs for a correctional officer to pull a double shift, she willingly accepts without hesitation to help prison administration in the time of need because she feels it's her call to duty." Officer Hunt was commended for her dedication, for her professional manner exhibited through her fair and impartial treatment of offenders, and for her willingness to strive to be the best in all that she undertakes.

Christie Scott, of Madison, received the Extra Effort award. Scott, a two-year veteran with CMCF serves as a Correctional Law Library Technician at the prison. Nominated by Gia McLeod, Director of the Inmate Legal Assistance Program (ILAP), Scott was commended for her dedication to the legal assistance program. "Scott has worked to educate herself with the background of the legal issues to assist inmates in my absence," said McLeod. "She has exhibited a willingness to learn more about the law and its application to the Inmate Legal Assistance Program and has taken on the duties in an assisting capacity on a day to day basis." Scott was commended for her desire to grow, learn and to assist the ILAP Director. Guzel Dempsey, Correctional Officer II of Jackson, was presented CMCF's Extra Effort Award. Johnson was commended for her professional manner in communicating with other agencies and the general public and was complimented on her spirit of cooperation, her enthusiasm, and her work performance.

Belita May, Correctional Officer I of Carthage, was presented MDOC's Extra Effort Award in recognition of her outstanding service at CMCF. May, who joined CMCF's ranks in February 2000, was nominated for her special employee recognition by Correctional Supervisor Sharon Paige. She was saluted for her loyalty to her job and her willingness to help others whenever called upon.
