SUBJECT: ON THE CRITERIA FOR THE SELECTION OF THE SCHOOL SUPERINTENDENT.

Dear School Committee Members:

Corrupt practices characterize Lowell City politics. Black's Law Dictionary (5th ed.) defines "corruption" as "[a]n act done with an intent to give some advantage inconsistent with official duty and the rights of others. The act of an official or fiduciary person who unlawfully and wrongfully uses his station or character to procure some benefit for himself or for another, contrary to duty and the rights of others."

I agree with the blue ribbon committee that candidates Helen Flanagan and Rosemary Leblanc-Considine do not belong in the short list of candidates, but neither does William Samaras.
