HINDS COMMUNITY COLLEGE TO UNDERTAKE MAJOR ENERGY EFFICIENCY UPGRADES

Hinds Community College, with its main campus located in Raymond, MS, has entered into a performance contract with Johnson Controls, Inc. (JCI), for \$5,037,537. Hinds will make improvements to lighting, heating, ventilation, and air-conditioning (HVAC); and energy management systems. They will also conduct water management and conservation improvements, waste management and telecommunications improvements, along with HVAC operational improvements. With all these improvements in place, Hinds will realize an estimated annual savings in energy cost expenditures of over \$800,000. This provides a payback of the initial cost in less than 7 years.

In addition, Johnson Controls, Inc., will offer an internship program whereby two college students can earn college credits while acquiring school-to-work experience at local JCI offices. JCI plans to construct a training lab with a fully functional facility management system for use by the students in HVAC maintenance curriculum. JCI plans to offer courses in energy conservation and management for the faculty and staff. Continuing education credits will be available for successful completion of the curriculum.

The Energy Division's role in energy efficiency performance contracting is to review the contract and provide technical assistance leading to the final approval of the contract by both parties.

YATES AWARDS MINORITY CONTRACTOR \$1.5 MILLION NISSAN CONTRACT

A Mississippi minority contractor has been awarded a \$1.5 million contract on the Nissan construction project.

Yates Construction, general contractor for the Nissan plant in Canton, recently selected Nelson Plumbing, founded in Nesbit in 1972, to provide services for a building on the site.

"This is a result of our hard work and efforts to include diversity on the Nissan Project," said Johnny Crisler, Minority Program Coordinator for Yates Construction. "Nelson Plumbing meets the criteria we have set. They bring quality work and true minority participation and will be an excellent partner."

Yates Construction held a workshop last spring to identify suppliers and vendors from throughout the state to assist in constructing the Nissan facilities. Special efforts are being made to attract qualified minority subcontractors.

"We are excited about the opportunity to work on a project of this magnitude," said Willie Nelson, CEO of Nelson Plumbing. "It's exciting for us and it is exciting for Mississippi. Yates and Walbridge-Aldinger have been fair and given us every opportunity to bid on the work."

Construction is underway on the facility and Crisler said efforts to offer minority contracts will continue throughout the project.

Yates, incorporated in 1964, has thirteen offices in seven states. The Yates Companies, Inc., which include W.G. Yates and Sons, JESCO Inc. and Blaine Construction, employs more than 2,500 and is the only Mississippibased company ranked in the top 58 of *Engineering News Record's* top 400 contractors in the country.

TTRA HOST ANNUAL CONFERENCE IN HOT SPRINGS

This week, officials from the Mississippi Development Authority and the automotive industry formally announced the creation of the Mississippi Automotive Manufacturers Association (MAMA).

MAMA, formed by the DelKen Group, Inc., was established to support the automotive manufacturers' interest in Mississippi. EMBDC TAKES OPTION ON DELCO REMY AMERICA BUILDING

Through a vote of the Meridian City Council, the 310,000 square foot available building in the South Industrial park will be under option from August 15 through October 31 by the East Mississippi Business Development Corporation.

"The EMBDC has been working closely with the City of Meridian and the Lauderdale County Board of Supervisors to secure a tenant for the facility vacated by Delco Remy America," said EMBDC Chairman Glen Deweese. "We are at a point in the negotiation process where we needed to have the building under option."

"This option agreement," said Mayor Smith, "underscores our belief that we have a marketable building that is attractive to new industry. We will continue to work with the EMBDC and the company to develop this property and bring new manufacturing jobs into our community."

Council President George Thomas said, "The request for option is an indication that progress is being made in securing a tenant for the Delco building. The City Council is working with the mayor and the EMBDC as negotiations with this prospect continue."

"We too are excited about the prospects of a quality company occupying the Delco Remy America building," said Lauderdale County Board of Supervisors' President Jimmie Smith. "The Board of Supervisors is ready to assist further, as it can, in making this opportunity become a reality."

While the name of the company was not given, Deweese and Mayor Smith did indicate the company is a supplier to the automotive industry and is expected to be working with automotive manufacturers in this region.

"We are excited about the potential of this deal," said Deweese. "The company has shown a commitment to the community that is not only verbal, but involves a considerable amount of money to be paid to the City of Meridian if it does not exercise this option."

INDUSTRIAL ENERGY EFFICIENCY TRAINING WORKSHOPS PLANNED

Officials with the Energy Division of the Mississippi Development Authority (MDA) are in the planning stages of offering a series of training workshops focusing on industrial energy efficiency. The Energy Division will work in concert with the Mississippi Manufacturers Association (MMA), Vocational Education Services and the Department Of Energy to conduct training sessions for manufacturers in the agriculture, forestry, aluminum, metal casting, steel, chemicals, petroleum, glass and mining industries. The workshops will be in addition to the one-to-one technical assistance presently provided to industries and businesses. allowing the Energy Division to impact a broader audience of industries in a shorter time frame. The program will assist plant owners, operators, and maintenance personnel in identifying areas within their operation that might use excessive energy and in identifying cost effective upgrades.

Workshops are planned in each region of the statenorthern, central and southern - by the end of the year. Each workshop will have concurrent sessions on the topics of motors, steam, compressed air, lighting, process heat, alternative fuels and financing. Each session will last approximately two hours starting at 8:00 a.m. and concluding at 5:00 p.m. Participants will have the opportunity to be trained in four subject areas in one day.

The first workshop will be held during the MMA quarterly meeting. Representatives from the Energy Division and the Department of Energy will provide a two-hour overview of programs and the benefits of participation. Speakers will explain details of the three introductory workshop-training sessions to be scheduled. Additional details will include information and software packages, lectures, financial options, certification programs and industry partners.
