SBA DECLARES HARRISON COUNTY DISASTER AREA

Homeowners, renters, landlords, and business owners, located in Harrison County and the contiguous Counties of Hancock, Jackson, Pearl River, and Stone are now eligible to apply for lowinterest disaster loan assistance from the U. S. Small Business Administration (SBA), Disaster Assistance Program. If you had some insurance, or no insurance, and had any damage caused by Tropical Storm Allison that occurred on June 11, 2001, you're eligible to apply for this help, according to SBA Disaster Area Director Michael C. Allen.

Allen announced that a temporary SBA disaster loan assistance office opened on Monday, July 2 at the Harrison County Court House in Gulfport. Beginning Monday, July 11, help will be available Monday through Saturday from 9:00 a.m. to 6:00 p.m., until further notice.

"We want everyone who had any damage caused by Tropical Storm Allison to come in and personally meet with an SBA loan officer. Our loan team will be glad to answer any questions about the disaster loan program, give you a disaster loan application, and provide any extra help you may need or want with completing the application," Allen said.

SBA offers loans of up to \$200,000 to repair disaster-damaged homes. Homeowners and renters are eligible for up to \$40,000 to replace personal property. Loans to businesses and non-profit organizations of up to \$1.5 million are also available to repair damage to real estate, machinery and equipment, inventory, etc. and leasehold improvements. Economic Injury Disaster Loans (EIDL) also may be made to small businesses unable to pay bills and meet expenses because of this disaster. Interest rates can be as low as 3.312 percent for homeowners and renters and 4 percent for businesses with terms up to 30 years. Actual loan amounts and terms are set by SBA and are based upon each applicant's financial condition.

The deadline for physical damage applications is August 27, 2001; the deadline for economic injury applications is March 26, 2002.

LAUREL LUMBER AWARDED ENERGY INVESTMENT LOAN

Laurel Lumber Company, a division of Thomasson Lumber in Laurel, Mississippi, was recently awarded a loan of \$300,000 by the Energy Division, Mississippi Development Authority (MDA). The loan, made possible by MDA's Energy Investment Loan Program, will be used to install wood-fired burner/boiler systems for two kiln drying units. By installing the burner and attached boiler, the kilns are modified to steam operation. The result will be an energy savings of approximately \$15,000 – \$25,000 per month for Laurel Lumber.

The Energy Investment Loan Program is one of the many programs that the Energy Division is employing to help business and industry cut energy costs and preserve natural resources.

HOME AND COMMUNITY DEVELOPMENT WORKSHOPS COMING THIS MONTH

The Community Services Division, MDA, will host two workshops in the month of July. The workshops target local units of government, nonprofit organizations, community housing development organizations (CHDOs), concerned citizens and other interested parties.
