TOWN OF PRENTISS AWARDED CDBG ECONOMIC DEVELOPMENT LOAN

The Town of Prentiss was recently awarded an Economic Development Loan under the Community Development Block Grant (CDBG) program in the amount of \$650,000. The original application was submitted on behalf of Partners in Progress, Inc.

Partners in Progress is expanding their existing manufacturing facility in Prentiss. With the loan, they will be able to add eight production lines and increase efficiency at the facility. Partners in Progress will invest \$200,000 in the project and the Town of Prentiss is investing \$40,129 toward the expansion effort.

The expanded facility will create 100 new jobs in the area. At least 51% of those jobs will be made available to low- and moderate-income persons.

MDA ACCEPTING APPLICATIONS FOR SMALL MUNICIPALITIES AND LIMITED POPULATION GRANT PROGRAM

Financial Services, a bureau of the Mississippi Development Authority is currently accepting grant applications from small municipalities and limited population counties or natural gas districts to finance projects promoting economic growth in Mississippi. The maximum grant amount, which may be awarded to any one local sponsor, will be \$250,000.

The amount of each grant awarded will be based on population, ability of the community to participate in the project, the economic impact the project will have on the community, and other criteria the Mississippi Development Authority develops. Each application is evaluated on it's own merit to meet the intent of the program.

A small municipality or a limited population county is defined as follows:

- Small Municipality a municipality with a population of 10,000 or less, according to the most recent federal decennial census, at the time the application is submitted by the municipality.
- Limited Population County a county with a population of 30,000 or less, according to the most recent federal decennial census, at the time the application is submitted by the county.
- Natural Gas Districts districts created by law and meeting the same requirements as small municipalities.

The deadline to submit applications is 4:00 pm on September 4, 2001. Funding is derived from appropriations or funds otherwise made available by the State Legislature.

SWEET POTATO GROWERS RECEIVE ENERGY GRANT FOR NEW EQUIPMENT

Sweet Potato Growers (SPG) Community
Development Corporation in Shelby, Mississippi,
recently purchased new state-of-the-art equipment
made possible with a grant from the Energy
Division, Mississippi Development Authority. The
funds were also used to purchase storage room kits
for curing potatoes and potato washing machinery.

At a cost of \$26,000 for a complete curing kit (which includes a cooling unit, circulation fans, levered venting windows, a heater and a humidifier), the Energy grant allowed SPG to purchase and install the equipment successfully.

Roger Morris of SPG stated during a recent site visit that before the addition of this equipment, individual growers suffered high percentages of crop spoilage due to inadequate curing and storage facilities. During 2000, SPG was able to bring growers together for the purpose of curing and storing the crop, which greatly saved their cooperative product, thus increasing profitability.

"MDA strives to empower communities on many levels, including agricultural development. We are delighted to be able to make such a tangible difference in the economy and livelihood of the citizens in Shelby," said Kenneth Calvin, Director of the Energy Division, MDA.

As SPG and the entire industry flourishes, the Delta region will experience economic growth through the creation of new jobs. That economic growth will be strengthened by the use of energy efficient equipment purchased through this and other MDA grants.
