USM'S ECONOMIC DEVELOPMENT COURSE DRAWS REGISTRANTS FROM 10 STATES

Two University of Southern Mississippi officials will be among keynote speakers Monday, Sept. 30, as USM's New South Economic Development course kicks off its 10th year with a week -long program at Hattiesburg's Lake Terrace Convention Center.

Dr. David Kolzow, associate professor and chair of USM's Economic Development Department, will lead two sessions on strategic planning starting at 8:50 a.m. and 10 a.m. Dr. Angie Dvorak, USM's vice president for research, will discuss technology transfer in a session starting at 1:15 p.m. About two dozen speakers will conduct other courses throughout the week. Mississippi Development Authority Executive Director Robert J. Rohrlack, Jr. will address a closing awards luncheon Friday, Oct. 4, speaking on "The Challenge of the Future." Rohrlack received a master's degree in USM's economic development program in 1985 and was a student of Dr. Ron Swager, director of the New South course.

Swager said nearly 60 people from 10 states – some from as far away as Michigan, Illinois, North Dakota and Utah – have registered for this year's course, which actually begins Sunday with continuing registration, orientation and a reception. USM President Shelby Thames was invited to make welcoming remarks.

"The registrants come from various backgrounds and places," said Swager. "Many are fairly new economic developers and many are from Mississippi. However, some are elected officials and representatives from Delta State University, Mississippi State and University of Mississippi; as well as port officials, railroad officials, representatives of the Jackson Medical Mall Foundation and some of our economic development students." Hattiesburg Mayor Johnny DuPree, who completed the USM course a couple of years ago, said, "It kind of gets you into the economic developer's shoes... gives you an understanding of some of the things you have to contend with in economic development."

The course, one of only 19 economic development courses in the country accredited by the American Economic Development Council, offers participants intensive training in the basic concepts, strategies and methods of economic development in the new South.

Participants who successfully complete the course qualify for admission to the Economic Development Institute and earn points toward qualifying to take the Certified Economic Developer examination.

Swager, a USM professor of economic development, said more and more elected officials, such as DuPree, are taking the course to get a better understanding of the process of attracting industry and developing the economy in the communities they serve. Under a general theme of the changing face of economic development, the six-day course will include presentations on the changing state of the region, how to plan for strategic change, community development, workforce preparedness and marketing.

Other topics include business retention and expansion, recruiting and prospect handling, site selection and economic development on the Internet.

The Mississippi Development Authority, the Mississippi Economic Development Council, the Southeast Mississippi Economic Development Network, the Area Development Partnership, Louisiana Generating LLC, Entergy Corporation and Mississippi Power Company sponsor the course. The cost of the course – \$550 per person – includes instruction and all course materials. An additional late registration fee has been assessed since Sept. 12.
