**HELEN OF TROY LOCATES NEW DISTRIBUTION CENTER IN DESOTO COUNTY**

JACKSON, Miss. – Governor Ronnie Musgrove, the Mississippi Development Authority and DeSoto County and Southaven officials along with Helen of Troy Limited announced that the company is locating its new eastern United States distribution center in Southaven. The project represents an investment in a 600,000 square foot facility expected to generate 50 jobs in the area. The company made the final selection of Southaven/DeSoto County after considering 11 other locations in 9 different states. The new facility will be in IDI's Airway Distribution Center's new spec building.

“Helen of Troy is a welcome addition to the business community in Southaven,” said Governor Musgrove. “The company's decision to locate in Mississippi demonstrates their confidence in the state's abilities to meet their business needs now and into the future. It also represents the state's ongoing effort to improve quality of life in our state and build corporate partnerships. Good jobs create good communities.”

The cooperation and support from the people of Mississippi at the local and state level has been tremendous,” concluded Rubin.
