The HOME Investment Partnerships Program is a housing grant program created by the National Affordable Housing Act of 1990 for the purpose of expanding the supply of safe, sanitary, and affordable housing, strengthening the ability of state and local governments to provide housing, and expanding the capacity of non-profit Community-Based Housing Development Organizations (CHDOs). HOME funds can be directed toward a wide variety of housing development activities including: homeowner rehabilitation, reconstruction, new construction, administrative costs and homebuyer assistance.

The Mississippi Development Authority (MDA) administers the program, which is funded by the U.S. Department of Housing an Urban Development to assist local units of government and community housing development organizations in their efforts to provide decent and affordable housing.
