- S.B. NO. 3185: AN ACT TO AMEND SECTION 37-59-111, MISSISSIPPI CODE OF 1972, TO INCREASE THE AUTHORIZED TERM TO MATURITY OF NOTES OR CERTIFICATES OF INDEBTEDNESS ISSUED BY SCHOOL DISTRICTS FOR CAPITAL IMPROVEMENT; AND FOR RELATED PURPOSES. (May 15, 2000; 2:45 PM)
- S.B. NO. 3207: AN ACT TO AUTHORIZE THE BOARD OF SUPERVISORS OF LAFAYETTE COUNTY, MISSISSIPPI, TO CONTRIBUTE ANNUALLY TO THE OXFORD-LAFAYETTE COUNTY ECONOMIC DEVELOPMENT FOUNDATION FOR THE NEXT FOUR COUNTY FISCAL YEARS; AND FOR RELATED PURPOSES. (May 15, 2000; 11:25 AM)
- **S.B. NO. 3220:** AN ACT TO AUTHORIZE THE BOARD OF SUPERVISORS OF HARRISON COUNTY, MISSISSIPPI, TO CONTRIBUTE TO FEED MY SHEEP, INCORPORATED; AND FOR RELATED PURPOSES. (May 15, 2000; 11:26 AM)
- S.B. NO. 3308: AN ACT TO AUTHORIZE THE BOARD OF SUPERVISORS OF WAYNE COUNTY, MISSISSIPPI, IN ITS DISCRETION, TO DONATE TO THE CITY OF WAYNESBORO, MISSISSIPPI, SUCH COUNTY-OWNED LANDS AS MAY BE NECESSARY FOR THE PURPOSE OF LENGTHENING AND WIDENING AND OTHERWISE COMPLETING THE AIRPORT RUNWAY EXPANSION PROJECT FOR THE WAYNESBORO MUNICIPAL AIRPORT. - **S.B. NO. 3346:** AN ACT TO AUTHORIZE THE GOVERNING AUTHORITIES OF THE CITY OF HOLLY SPRINGS, MISSISSIPPI, TO EXPAND ITS NATURAL GAS, WATER AND SEWER SYSTEM WITHIN A CERTAIN AREA OUTSIDE THE CORPORATE LIMITS OF THE CITY OF HOLLY SPRINGS; AND FOR RELATED PURPOSES. (May 15, 2000; 11:31 AM)

**S.B. NO. 3348:** AN ACT TO AUTHORIZE THE GOVERNING AUTHORITIES OF THE CITY OF PASCAGOULA, MISSISSIPPI, TO CONVEY AND DONATE CERTAIN PROPERTY TO THE UNITED STATES OF AMERICA FOR THE PURPOSE OF CONSTRUCTING HOUSING THEREON FOR NAVY PERSONNEL; AND FOR RELATED PURPOSES. (May 15, 2000; 11:32 AM)
