## TO THE MISSISSIPPI STATE SENATE:

I am directed by the Governor to advise you that he has approved the following Senate Bills:

- **S.B. NO. 3080:** AN ACT TO DESIGNATE A PORTION OF U.S. HIGHWAY 84 IN ADAMS COUNTY AS THE DELVRU JOHN ANTHONY MINOR MEMORIAL HIGHWAY; AND FOR RELATED PURPOSES. (April 17, 2000; 6:39 AM)
- S.B. NO. 3085: AN ACT TO AUTHORIZE THE DEPARTMENT OF WILDLIFE, FISHERIES AND PARKS TO TRANSFER TO THE DEPARTMENT OF FINANCE AND ADMINISTRATION THE LAND AND BUILDING, FORMERLY KNOWN AS THE MISSISSIPPI MUSEUM OF NATURAL SCIENCE, LOCATED ADJACENT TO THE STATE FAIRGROUNDS IN THE CITY OF JACKSON, COUNTY OF HINDS, MISSISSIPPI; AND FOR RELATED PURPOSES. - **S.B. NO. 3103:** AN ACT TO AMEND SECTION 9-13-121, MISSISSIPPI CODE OF 1972, TO REVISE THE GIVING OF EXAMINATION FOR CERTIFICATION AS A COURT REPORTER, NOTICE, THE EFFECT OF NOT PASSING THE EXAMINATION, AND TEMPORARY CERTIFICATES; AND FOR RELATED PURPOSES. (April 17, 2000; 6:40 AM)
- **S.B. NO. 3130:** AN ACT TO PROTECT VICTIMS OF FELONY PARENTAL CHILD SEXUAL ABUSE; TO ENACT STANDARDS; TO CREATE A LOCAL REGISTRY; TO ENACT PENALTIES; AND FOR RELATED PURPOSES. (April 17, 2000; 6:41 AM)
- **S.B. NO. 3131:** AN ACT TO DESIGNATE AND NAME A BRIDGE ACROSS REEDY CREEK ON MISSISSIPPI HIGHWAY 537 IN JONES COUNTY AS THE "E.C. GABLE MEMORIAL BRIDGE;" AND FOR RELATED PURPOSES. (April 17, 2000; 6:42 AM)
- S.B. NO. 3146: AN ACT TO PROMOTE HUNTER SAFETY FOR CHILDREN BELOW LICENSE AGE, TO REDUCE HUNTING ACCIDENTS OF SUCH CHILDREN; TO PROTECT THE SAFETY OF SUCH CHILDREN; TO REQUIRE CERTAIN CHILDREN UNDER 16 YEARS OF AGE TO TAKE HUNTER EDUCATION; TO REQUIRE AN ADULT TO BE WITH A CHILD UNDER THE AGE OF 12 WHILE HUNTING; AND FOR RELATED PURPOSES. (April 17, 2000; 6:42 AM)

- S.B. NO. 3147: AN ACT TO AMEND SECTION 31-5-51, MISSISSIPPI CODE OF 1972, TO REQUIRE PROOF OF GENERAL LIABILITY INSURANCE BEFORE ENTERING INTO CERTAIN FORMAL CONTRACTS WITH THE STATE OR ANY COUNTY, CITY OR POLITICAL SUBDIVISION THEREOF, OR OTHER PUBLIC AUTHORITY FOR THE CONSTRUCTION, ALTERATION, OR REPAIR OF ANY PUBLIC BUILDING OR PUBLIC WORK; AND FOR RELATED PURPOSES. (April 17, 2000; 9:15 AM)
- **S.B. NO. 3160:** AN ACT TO AMEND SECTIONS 43-17-37 AND 43-17-35, MISSISSIPPI CODE OF 1972, TO MAKE TECHNICAL CORRECTIONS TO THE MISSISSIPPI REDUCING OUT-OF-WEDLOCK PREGNANCIES INCENTIVE GRANT FUND PROGRAM, AND TO EXTEND THE TASK FORCE ON OUT-OF-WEDLOCK PREGNANCIES IN ORDER TO MAKE FURTHER REPORTS TO THE LEGISLATURE; AND FOR RELATED PURPOSES. (April 17, 2000; 6:43 AM)
- **S.B. NO. 3188:** AN ACT TO CONFIRM AND DECLARE LEGISLATIVE INTENT WITH REGARD TO THE PROVISION OF LAW REQUIRING BOARDS OF SUPERVISORS TO ADOPT AN OFFICIAL MAP DESIGNATING AND DELINEATING ALL PUBLIC ROADS ON THE COUNTY ROAD SYSTEM; AND FOR RELATED PURPOSES. (April 17, 2000; 6:44 AM)
- S.B. NO. 3232: AN ACT TO AUTHORIZE THE HANCOCK COUNTY BOARD OF SUPERVISORS TO APPOINT A SEVEN-MEMBER COMMISSION TO SUPERVISE THE ADMINISTRATION AND MANAGEMENT OF THE HANCOCK COUNTY MULTIPURPOSE EQUINE AND LIVESTOCK FACILITY; TO PROVIDE FOR THE MEMBERSHIP OF THE COMMISSION; TO TRANSFER ALL POWERS AND DUTIES, FUNDS AND FACILITIES OF THE HANCOCK COUNTY EQUINE AND LIVESTOCK FACILITY BOARD TO HANCOCK COUNTY; TO ABOLISH THE HANCOCK COUNTY EQUINE AND LIVESTOCK FACILITY BOARD; AND FOR RELATED PURPOSES. (April 17, 2000; 6:45 AM)
