NO. 2078: AN ACT TO AMEND SECTION 49-7-41, MISSISSIPPI CODE OF 1972, TO EXTEND THE DATE OF THE REPEALER ON THE PROVISION OF LAW THAT AUTHORIZES THE COMMISSION TO ESTABLISH BAG LIMITS FOR GAME ANIMALS, BIRDS AND FISH; TO CLARIFY CERTAIN LANGUAGE CONCERNING THE ANNUAL BAG LIMIT ON ANTLERED BUCK DEER; TO REDUCE THE BAG LIMIT ON ANTLERLESS DEER PER LICENSE YEAR; AND FOR RELATED PURPOSES. (April 30, 2000; 3:24 PM)

**S.B. NO. 2158:** AN ACT TO AUTHORIZE THE BOARD OF SUPERVISORS OF ANY COUNTY IN THE YAZOO BASIN, YAZOO BACKWATER, MISSISSIPPI, PROJECT AREA, TO REQUIRE LANDOWNERS WHO SELL REFORESTATION EASEMENTS IN SUCH PROJECT AREA TO ANNUALLY PAY A FEE ON EACH ACRE OF PROPERTY FOR WHICH A LANDOWNER SOLD SUCH AN EASEMENT FOR PURPOSES SPECIFICALLY RELATED TO THE PROJECT; TO LIMIT THE AMOUNT OF SUCH FEE; TO PROVIDE THAT THE PROCEEDS OF THE FEE SHALL BE USED BY THE BOARD OF SUPERVISORS TO PROVIDE SERVICES SUCH AS ROAD MAINTENANCE, FIRE PROTECTION AND POLICE PROTECTION AND OTHER SERVICES NECESSARY FOR THE MAINTENANCE AND PROTECTION OF REFORESTATION EASEMENTS IN THE PROJECT AREA; AND FOR RELATED PURPOSES. **S.B. NO. 2470:** AN ACT TO AUTHORIZE THE ISSUANCE OF GENERAL OBLIGATION BONDS OF THE STATE OF MISSISSIPPI FOR THE PURPOSE OF RIGHT-OF-WAY ACQUISITION NECESSARY TO COMPLETE THE TERMINUS OF THE NATCHEZ TRACE PARKWAY IN NATCHEZ, MISSISSIPPI; AND FOR RELATED PURPOSES. (April 30, 2000; 3:31 PM)

S.B. NO. 2840: AN ACT TO AMEND SECTION 43-19-34, MISSISSIPPI CODE OF 1972, TO PROVIDE FOR REVIEW ON A 3-YEAR CYCLE FOR POSSIBLE MODIFICATION OF CHILD SUPPORT ORDERS, AND TO PROVIDE THAT ONLY UPWARD, NOT DOWNWARD, ADJUSTMENTS MAY BE ORDERED RETROACTIVELY; TO AMEND SECTION 43-19-45, MISSISSIPPI CODE OF 1972, TO PROVIDE THAT FULL FAITH AND CREDIT BE GIVEN TO THE NOTICES AND SUBPOENAS ISSUED BY OTHER STATES; TO AMEND SECTION 43-19-101, MISSISSIPPI CODE OF 1972, TO PROVIDE THAT ALL CHILD SUPPORT ORDERS SHALL ORDER REASONABLE MEDICAL SUPPORT; TO AMEND SECTIONS 93-9-15 AND 93-9-27, MISSISSIPPI CODE OF 1972, TO PROVIDE THAT THERE IS NO RIGHT TO A TRIAL BY JURY IN AN ACTION TO ESTABLISH PATERNITY; TO AMEND SECTION 93-11-65, MISSISSIPPI CODE OF 1972, TO PROVIDE THAT TEMPORARY SUPPORT IS TO BE GRANTED PENDING A DETERMINATION OF PARENTAGE; TO AMEND SECTIONS 93-11-103 AND 93-11-105, MISSISSIPPI CODE OF 1972, TO PROVIDE THAT NOTICE OF AN ADMINISTRATIVE ORDER FOR CHILD SUPPORT MAY BE GIVEN THROUGH REGULAR MAIL TO THE LAST KNOWN ADDRESS OF THE OBLIGOR; AND FOR RELATED PURPOSES. (April 30, 2000; 3:32 PM)

S.B. NO. 2943: AN ACT TO AMEND SECTIONS 7-9-151, 7-9-153 AND 7-9-155, MISSISSIPPI CODE OF 1972, TO REVISE THE PURPOSES FOR WHICH FUNDS IN THE CAPITAL IMPROVEMENTS PREPLANNING FUND MAY BE EXPENDED; TO PROVIDE THAT SECTIONS 7-9-151 THROUGH 7-9-159, MISSISSIPPI CODE OF 1972, SHALL BE REPEALED FROM AND AFTER JULY 1, 2003; TO AMEND SECTION 31-11-27, MISSISSIPPI CODE OF 1972, TO REQUIRE THE DEPARTMENT OF FINANCE AND ADMINISTRATION TO PREPARE AND FILE AN ANNUAL REPORT WITH THE LEGISLATIVE BUDGET OFFICE, THE HOUSE PUBLIC BUILDINGS, GROUNDS AND LANDS COMMITTEE AND THE SENATE PUBLIC PROPERTY COMMITTEE DESCRIBING THE PROPOSED FIVE-YEAR CAPITAL NEEDS OF STATE AGENCIES; TO PROVIDE CERTAIN INFORMATION THAT SUCH REPORT MUST CONTAIN; TO PROVIDE THAT STATE CAPITAL IMPROVEMENTS PROJECTS COSTING ONE MILLION DOLLARS OR MORE SHALL BE FUNDED BY THE LEGISLATURE IN TWO PHASES; TO DEFINE EACH PHASE; TO PROVIDE THAT EACH PHASE SHALL BE FUNDED IN SEPARATE SESSIONS OF THE LEGISLATURE; TO EXEMPT CERTAIN PROJECTS FROM SUCH **REQUIREMENTS; TO REQUIRE ALL STATE AGENCIES WHICH** PLAN TO UNDERTAKE A CAPITAL IMPROVEMENTS PROJECT TO SUBMIT A PREPLANNED CAPITAL IMPROVEMENTS PROJECT PROJECTION TO THE BUREAU OF BUILDING, GROUNDS AND REAL PROPERTY MANAGEMENT FOR EVALUATION; TO PROVIDE THAT ANY PROJECT COSTING UNDER ONE MILLION DOLLARS SHALL NOT BE REQUIRED TO BE PREPLANNED; AND FOR RELATED PURPOSES. (April 30, 2000; 3:34 PM)

S.B. NO. 3194: AN ACT TO AUTHORIZE THE ISSUANCE OF GENERAL OBLIGATION BONDS OF THE STATE OF MISSISSIPPI IN THE AMOUNT OF \$3,000,000.00 FOR THE PURPOSE OF ASSISTING PUBLIC UTILITY DISTRICTS ESTABLISHED BY THE COUNTY FOR THE PROVISION OF SERVICES FOR MASTER PLANNED COMMUNITIES FOR THE CONSTRUCTION FOR MASTER PLANNED COMMUNITY OR WATER PRODUCTION AND DISTRIBUTION FACILITIES AND WASTEWATER TREATMENT AND COLLECTION FACILITIES; AND FOR RELATED PURPOSES. (April 30, 2000; 3:35 PM) S.B. NO. 3231: AN ACT TO AUTHORIZE THE CITY OF PHILADELPHIA, MISSISSIPPI, TO ISSUE BONDS IN THE MAXIMUM PRINCIPAL AMOUNT OF \$1,500,000.00 FOR THE PURPOSE OF CONSTRUCTING AND EQUIPPING A WAREHOUSE FACILITY ON PROPERTY OWNED BY THE CITY; TO AUTHORIZE THE CITY TO LEASE SUCH WAREHOUSE FACILITY; TO AUTHORIZE THE CITY AND THE BOARD OF SUPERVISORS OF NESHOBA COUNTY TO ENTER INTO AN AGREEMENT TO PAY THE DEBT SERVICE ON THE BONDS ISSUED PURSUANT TO THIS ACT IN CERTAIN SITUATIONS; AND FOR RELATED PURPOSES.
