TO THE MISSISSIPPI STATE SENATE:

**S.B. NO. 2135:** AN ACT TO AMEND SECTION 73-7-63, MISSISSIPPI CODE OF 1972, TO EXTEND THE DATE OF THE AUTOMATIC REPEALER ON THOSE STATUTES WHICH CREATE THE STATE BOARD OF COSMETOLOGY AND PRESCRIBE ITS DUTIES AND POWERS; AND FOR RELATED PURPOSES. (March 29, 2001; 5:40 AM)

**S.B. NO. 2745:** AN ACT TO AMEND SECTION 43-13-117, MISSISSIPPI CODE OF 1972, TO SPECIFY AND LIMIT THE TYPE OF IMPLANTABLE PROGRAMMABLE PUMP FOR WHICH HOSPITALS WILL RECEIVE AN ADDITIONAL PAYMENT UNDER MEDICAID; TO EXTEND THE REPEAL

DEBIT CARDS AND OTHER ELECTRONIC FUNDS TRANSFERS FOR PAYMENT OF GOVERNMENT FEES, COSTS AND DEBTS IN ACCORDANCE WITH POLICIES ADOPTED BY THE STATE AUDITOR; TO PROVIDE THAT ANY FEES OR CHARGES ASSOCIATED WITH THE USE OF SUCH ELECTRONIC PAYMENTS SHALL BE ASSESSED TO THE USER OF THE ELECTRONIC PAYMENT AS AN ADDITIONAL CHARGE FOR PROCESSING THE ELECTRONIC PAYMENT; TO AUTHORIZE MEMBERS OF COUNTY BOARDS OF SUPERVISORS AND COUNTY EMPLOYEES TO USE CREDIT CARDS TO PAY TRAVEL EXPENSES INCURRED IN THE PERFORMANCE OF THEIR OFFICIAL DUTIES; AND FOR RELATED PURPOSES. (March 29, 2001; 5:25 AM)

**S.B.
