TO THE MISSISSIPPI HOUSE OF REPRESENTATIVES:

I am directed by the Governor to advise you that he has approved the following House Bills:

MISSISSIPPI CODE OF 1972, TO ENACT INTO LAW THE NURSE LICENSURE COMPACT AND PROVIDE THAT THE STATE OF MISSISSIPPI ENTERS THE COMPACT WITH OTHER STATES THAT JOIN IN THE COMPACT: TO PROVIDE THAT UNDER THE COMPACT.
