TO THE MISSISSIPPI HOUSE OF REPRESENTATIVES:

I am directed by the Governor to advise you that he has approved the following House Bills:

**H.B. NO. 1600:** AN ACT TO AMEND CHAPTER 50, LAWS OF THE FIRST EXTRAORDINARY SESSION OF 1964, AS LAST AMENDED BY CHAPTER 982, LOCAL AND PRIVATE LAWS OF 1999, TO AUTHORIZE THE BOARD OF SUPERVISORS OF HARRISON COUNTY TO ALLOW THE OWNER OF A PARCEL BEING DEVELOPED AS A MASTER PLANNED COMMUNITY TO DESIGNATE RESIDENTS OR NONRESIDENTS OF A PUBLIC UTILITY DISTRICT INCORPORATED IN CONNECTION WITH THE MASTER PLANNED COMMUNITY FOR APPOINTMENT BY THE BOARD OF SUPERVISORS TO THE UTILITY DISTRICT'S BOARD OF COMMISSIONERS, AND TO AUTHORIZE THE PUBLIC UTILITY DISTRICT TO PROVIDE DRAINAGE AND RECREATION SERVICES; AND FOR RELATED PURPOSES. (May 5, 2000; 6:30 AM)

**H.B. NO. 1704:** AN ACT TO AUTHORIZE THE BOARD OF SUPERVISORS OF TALLAHATCHIE COUNTY TO CONTRACT WITH THE TALLAHATCHIE COUNTY FAIR ASSOCIATION, INC., FOR REPAIR, RENOVATION, IMPROVEMENT, EQUIPPING AND/OR CONSTRUCTION WORK ON CERTAIN COUNTY FACILITIES, AND FOR MAKING OTHER REPAIRS, RENOVATIONS, IMPROVEMENTS AND/OR EQUIPPING OF THOSE FACILITIES; TO AUTHORIZE THE BOARD OF SUPERVISORS TO EXPEND CERTAIN SUMS TO FUND THE CONTRACT WITH THE ASSOCIATION AND TO MAKE THE NECESSARY REPAIRS, RENOVATIONS, IMPROVEMENTS AND/OR EQUIPPING OF THOSE FACILITIES; AND FOR RELATED PURPOSES. **H.B. NO. 1710:** AN ACT TO AUTHORIZE THE GOVERNING AUTHORITIES OF THE CITY OF TUNICA, MISSISSIPPI, TO CONTRIBUTE FUNDS TO THE TUNICA COUNTY CHAMBER OF COMMERCE; TO REQUIRE THE TUNICA COUNTY CHAMBER OF COMMERCE TO HAVE ITS BOOKS AUDITED BY A CERTIFIED PUBLIC ACCOUNTANT; AND FOR RELATED PURPOSES. (May 5, 2000; 6:45 AM)

**H.B. NO. 1712:** AN ACT TO AUTHORIZE THE CITY OF WEST POINT, MISSISSIPPI, TO EXPAND ITS WATER AND SEWER SYSTEM WITHIN A CERTAIN DISTANCE OUTSIDE THE CORPORATE LIMITS OF THE CITY OF WEST POINT; TO AUTHORIZE THE CITY OF WEST POINT TO ACQUIRE AND ASSUME THE OPERATION AND

MAINTENANCE OF THE STRONG HILL WATER ASSOCIATION AND TO ASSUME ALL THE LIABILITIES, OBLIGATIONS, ASSETS, DUTIES AND RESPONSIBILITIES OF SUCH ASSOCIATION; AND FOR RELATED PURPOSES. (May 5, 2000; 6:46 AM)

**H.B. NO. 1716:** AN ACT TO AUTHORIZE THE CITY OF BOONEVILLE AND THE TOWN OF RIENZI TO ENTER INTO AN AGREEMENT PROVIDING FOR THE SALE OF NATURAL GAS AND RELATED SERVICES BY BOONEVILLE TO RIENZI; AND FOR RELATED PURPOSES. (May 5, 2000; 6:50 AM)

**H.B. NO. 1728:** AN ACT TO AUTHORIZE THE BOARD OF SUPERVISORS OF COVINGTON COUNTY TO DONATE A CERTAIN SUM OF MONEY TO THE BOYS AND GIRLS CLUB OF COVINGTON COUNTY, MISSISSIPPI; AND FOR RELATED PURPOSES. (May 5, 2000; 6:51 AM)
