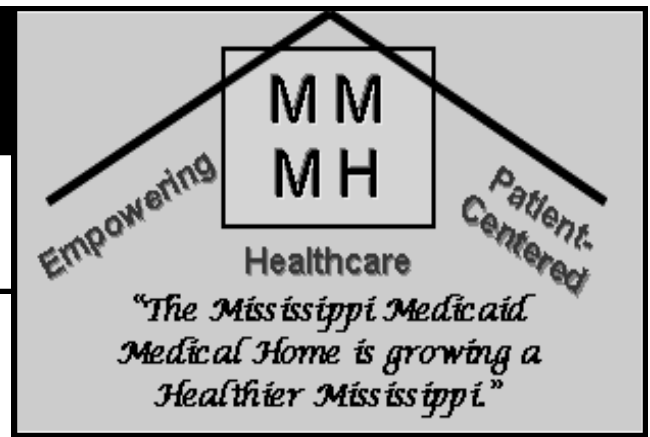


Mentally Retarded/ Developmentally Disabled (MR/DD) Waiver

Home and Community-Based Services



What is the MR/DD Waiver?

The MR/DD Waiver is a statewide program, administered jointly by the Division of Medicaid and the Department of Mental Health, Bureau of Mental Retardation. It is designed to offer assistance to qualified Medicaid beneficiaries.

This program allows qualified individuals to remain in a home or community-based setting.

Who is qualified?

- There are no age restrictions.
- Persons qualify for Medicaid by either SSI or 300% of SSI; Temporary Assistance to Needy Families (TANF); or a disabled child living at home.
- Beneficiaries must be mentally retarded and developmentally disabled.
- Beneficiaries must be persons who, without assistance, would be appropriate for ICF/MR level of care.

All persons who are eligible to receive Home and Community-Based Services under this waiver must first be approved through the Division of Medicaid.

What services are offered under this waiver?

Habilitation

This service is designed to assist individuals in acquiring, retaining, and improving the self-help, socialization, and adaptive skills necessary to reside successfully in home and community-based settings.

Currently the waiver offers: Day Habilitation, Residential Habilitation, Prevocational Services, and Supported Employment Services.

Behavior Support/Intervention

This service provides behavioral support/ intervention for individuals who show behavior problems that cause them not to be able to benefit from other services being provided or cause them to be so disruptive in their environment(s) that there is imminent danger of institutionalization.

Respite Care

This service is given to individual(s) unable to care for themselves. Respite Care is provided on a short term basis because of the absence or need for relief of those persons normally providing the care.

Currently the waiver offers: In-Home Respite-Companion and Nursing, ICF/MR Respite, and Community Respite.

Support Coordination

Everyone who participates in this waiver is assigned to a Mental Health Support Coordinator. The purpose of the support coordinator is to monitor the services included in the beneficiary's plan of care and to reevaluate annually the level of care required for each participant.

More Information 

Attendant Care Services

These services are provided to meet daily living needs and to ensure adequate support for optimal functioning at home or in the community, but only in non-institutional settings.

Attendant Care Services may include bathing, personal grooming and dressing, personal hygiene, toileting, transferring, assisting with ambulation, etc.

Specialized Medical Supplies

These include supplies specified on the plan of care and ordered by a physician. They enable individuals to increase their abilities to perform activities of daily living and, thus, avoid institutionalization. Covered supplies include diapers and under pads.

Other Services

Physical Therapy, Occupational Therapy, and Speech, Hearing, and Language Therapy are also available under this waiver.
